Harvest has concluded, and the weather is allowing farmers to complete fall tasks, but the drought concern is ever-present. Thank you for implementing the best land management practices to ensure erosion control and weed suppression. The MD of Taber collaborates with Farming Smarter. If you are interested in reviewing innovative research, Agriculture Services is available to answer questions and provide support related to the Weed, Soil, and Pest Acts under their jurisdiction.

Entering the winter season prompts reflection and planning for the forthcoming growing season. However, it can also be a time of solitude and challenges. We encourage everyone to check in on neighbours or anyone facing difficulties. Farm Family Counseling Services, facilitated through FCSS, is available, offering ten confidential in-person or remote sessions. They are available to assist individuals and families in managing anxiety, stress,

depression, and suicide. Reach out at **587-370-3728** or email counsellingservices@fcss.ca. For immediate mental health emergencies or crises, please call 9-1-1.

Five Councillors attended the Rural Municipalities Association Fall conference. Besides an opportunity to network and advance the municipality, they met Minister of Environment and Protected Areas Rebecca Schultz to request additional Horsefly Spillway Project funding due to inflationary shortfalls and coordinate a meeting with the Minister and our agriculture processors. Minister of Agriculture and Irrigation RJ Sigurdson's meeting focused on improving water security through increased on and off-stream storage, with a priority on Eyremore Dam and accessing adequate funding for infrastructure development to support irrigation expansion and the Agri Food Corridor. Importantly, the MD of Taber's resolution to ensure every area of Alberta has available ambulances with

qualified emergency personnel was successful. We are advocating alongside the Town of Vauxhall to ensure our residents receive timely life-saving responses from EMS.

Crucial reviews are underway, each with a public consultation phase. Keep an eye out for meeting dates and opportunities for online submissions on topics including the Land Use Bylaw, Land Management Plan: policy for grazing leases, tax recovery land, cultivation leases, and a Transportation Plan affecting the future of road networks.

Barnwell Firehall hosted a successful open house, with excellent engagement between firefighters and residents. Council is grateful for the dedication and expertise of our 90 volunteer firefighters, including the Station Chiefs, for providing a rapid response fire and rescue service. Thank you to firefighter families for their sacrifice and employers who support firefighters' call attendance.

The Enchant Subdivision is complete, with 35 lots available for purchase. Two Rural Highway Commercial lots are available adjacent to the Vauxhall Truck Stop, and we are underway with the Grassy Lake Subdivision, with lots anticipated in the fall of 2024. Lot details are available on the website.

Join us for Coffee with Council on February 7 at 7:00 pm at the Enchant Community Hall for an informal gathering open to all residents to voice comments or concerns. Additionally, every Council meeting offers opportunities for individuals to address Council in person or virtually. If it's a formal matter, you can request its addition to the agenda via our website or by contacting the office at 403-223-3541. Councillors are always open to emails or calls.

Council is midway through deliberations on the 2024 Capital and Operating budget. It's a challenging process, but we aim to create a budget that optimizes your tax dollars, ensuring quality transportation networks and services. Our focus also includes supporting committee initiatives such as housing, libraries, recreation, and economic development amidst economic pressures.

INFRASTRUCTURE PROGRAM 2023

> Grassy Lake North Subdivision

Phase 1 of the Grassy Lake North Subdivision is currently in the design stages. This project will see 40+ new residential lots available for purchase in the near future.

> 2023 Shoulder Pull Program

The construction season wrapped up the end of November. A total of 26 kilometres of shoulder pulls were completed this year.

> Grassy Lake Stormwater Study

A consultant was hired to complete a stormwater study of Grassy Lake and the final report is due the end of December 2023. We will present a schedule of projects along with a detailed maintenance plan following the study's completion.

> Range Road 17-3 Grade Widening

The contract has been awarded to McNally Contractors. The project consists of widening the grade for 700 metres, followed by a 2-kilometre asphalt overlay. The finishing touches on project are expected to be completed in first part of December.

> Vauxhall Airport Paving

The contract has been awarded to McNally Contractors. The project consists of an expansion of the taxiway. The project was completed mid-September.

> Grassy lake landfill reclamation

The contract has been awarded to East Butte Contractors. This project will remove landfill waste from a historic landfill on the north side of grassy lake. Once completed it will make way for a residential subdivision to be built nearby.

HORSEFLY EMERGENCY SPILLWAY UPDATE

Phase 1: Taber Lake to Oldman River

Significant strides have been made; the section spanning from Taber Lake to the third structure (1165 meters) is finished, boasting completed rock armor and operational drop structures. Progress throughout the summer has allowed for 98% completion of the road crossing at Highway 36, albeit with reduced speed limits due to ongoing work on the bypass.

Concrete structures (5) and box culvert road crossings (4) are fully constructed, facilitating the opening of all roads for use. Currently, work in the coulee has commenced, obliging compliance with the Historical Resources Act Approval, necessitating a Paleontologist's presence during excavation.

Upcoming tasks involve completing drainage ditch excavation and bank building, aiming for substantial completion by March 15, 2024. Environmental measures have been diligently executed, with an environmental company ensuring the safe relocation of rattlesnakes to their hibernation sites on October 15th.

Key approvals, including the Department of Fisheries and Oceans (DFO), have been secured. The DFO approval dictates necessary mitigations and contractor compliance for work

near the Oldman River entrance. Notably, Phase 1 remains within the stipulated budget.

The project's efficient progression showcases substantial achievements and adherence to regulatory measures, emphasizing environmental stewardship while maintaining project momentum within set constraints.

Phase 2: Horsefly Reservoir to Taber Lake

Phase 2 of the Highway 3 Twinning project near Taber is in its final design phase. MPE and Stantec have collaborated with CP Rail for the rail crossing design. Two of three phases incorporate wetland components as per provincial mandates. Alberta Transportation will fund the necessary Highway 3 crossings. Additionally, Phase 2 involves crossing Lantic Sugar's railroad spur line, with positive discussions and cooperation from their accommodating staff.

Phase 3: SMRID Main Canal to Horsefly Reservoir

Phase 3 construction, slated for Fall/Winter 2024/2025, awaits funding confirmation before tendering. Simultaneously tendering Phase 2 and Phase 3 separately in summer 2024 is the plan if funding aligns. This strategy aims to expedite progress while ensuring adequate financial backing for the upcoming construction phases.

4 HIDDEN DANGERS OF SNOW PILES

Ever wondered how dangerous a snow pile can be?

Here are 4 reasons why piling your "Private Snow" on roads is a "No".

1. It's dangerous to others

When snow from private properties encroaches on the roadway, motorists may have difficulty seeing oncoming traffic or pedestrians. The snow also reduces the space available for pedestrians and vehicles to share the road, and that can bring them dangerously close together in possibly slippery conditions.

2. Snow piles interfere with plowing

Piles of snow on municipal roads are also an issue for our maintenance operators because they are obstacles to plowing. A grader and loader may be brought in to remove the snow. Our budgets are not intended for clearing "private snow" off public property.

When plows need to detour around piles of snow or can not remove snow from the road due to large deposits that must first be removed, everyone who travels the area gets a lower level of maintenance. Our operators make an effort not to block private accesses and driveways during road plowing operations.

3. Drainage and damage problems

Piling snow into ditches is also a "snow-no." Why's that? Snow piles can interfere with drainage, causing damage to both public and private property. You could find yourself in a costly conflict with a neighbour or the Province of Alberta.

4. Unauthorized use of right-of-ways

In accordance with Section 3(14) of our Unauthorized Use of Municipal Property Bylaw No 1806, moving snow onto a municipal right-of-way (eg. municipal roads, ditches, bridges) is considered unauthorized use. People who do not comply may have to pay for the removal of the snow if it is deemed a safety hazard or a risk of damaging public infrastructure or damages infrastructure.

DEVELOPMENT PERMITS



Do I require a Development Permit for my farm building?

Understanding the necessity of a Development Permit for your farm building is crucial. To determine whether a Development Permit is required, consider the following criteria:

- › Will the farm building be erected within a proximity of fewer than 150 feet to the center line of the nearest road right-of-way, be it developed or undeveloped?
- › Does the intended location of the farm building fall within the 350-foot intersection site triangle setback?
- › Is there a plan to install a septic system within the confines of the farm building?
- › Are there intentions to construct the building in close proximity to a coulee or waterbody?
- › Is the inclusion of sleeping or living quarters part of the building design?
- › Are there pipelines or other easements in the vicinity of the proposed building?

The questions listed are a few of the more common questions we ask of applicants when it comes to farm buildings that require a permit.

SMALL BUSINESS SUBCLASS



Is all or part of your property eligible to qualify as a small business in the MD of Taber?

Until recently, businesses were charged the same property tax rate regardless of their size. The small business subclass can offer, at the discretion of Council, up to a 25 per cent in tax savings compared to other non-residential properties.

Non-residential class has been divided into 3 subclasses, defined in related regulations as follows:

- › Vacant non-residential property
- › Small business property
- › Other non-residential property

This allows Council the opportunity to consider differentiating tax rates for each non-residential subclass during the annual budget process.

In order to be considered as non-residential subclass for the 2024 tax year, submit your small business application on or before February 15th, 2024.
